**This bulletin is directed to owners of HTC developments that have been identified, by MHC, as being potentially eligible for funding through the subject gap funding program.**

The Mississippi Home Corporation (MHC) and the Mississippi Development Authority (MDA) have entered into an agreement to administer approximately \$16 million of the state's Disaster Recovery Community Development Block Grant (CDBG) funds to certain developments located in Pearl River, Harrison, Hancock, and Jackson counties. This program intends to provide additional financing to enable the development of previously funded properties that have encountered a financing gap due to decreased syndication pricing.

MHC began accepting applications on December 1, 2008. The deadline for submitting an application package is **March 25, 2009**. Applicants who have already applied may submit supplemental information to address any changes relative to the application package until this deadline date. The maximum anticipated loan amount is \$2,500,000. However, the State has the authority to increase the maximum loan amount on a case by case basis and may waive the maximum amount. The State reserves the right to negotiate the loan amount on each project.

Additionally, HUD Labor Specialists will be conducting Labor Relations training in Jackson, MS on Tuesday, March 24. Please see the attached announcement for more information. TCAF applicants are welcome and encouraged to attend.
